(A damaged bow is one that was dry fired, came off the wheel during the program, or incurred any other damage during the program that the instructor is concerned about in order to have them looked at by a professional.)

\_\_\_ I have read and understand how to adjust the Genesis bows properly in order to change the weight of the bows to fit the girls better.

\_\_\_ I understand that if the date I picked conflicts with an archery club date or event then my date will be denied and I will need to secure another date or alternative.

\_\_\_ I will be able to pick up the equipment between the hours of 8:30am -6pm, Monday-Thursday and 8:30am-3pm on Fridays. (This will require you to have a vehicle that is large enough for the equipment to be transported safely).

\_\_\_ I will not roll the targets through the grass, but will carry them in order to prevent turf build up in the wheels of the targets.
